Whereas, the Windsor Court Condominium is a condominium residence located at 175 Rochelle Avenue; and

Whereas, a request has been made by the management company of this condominium project for reimbursement of a portion of the cost of those services; and

Whereas, the Township has determined that it would be necessary and appropriate to apply the same formula for reimbursement as has been applied to other similar projects within the Township; and

Comm. Davidson – Thanked the Police Department for their continued efforts. He advised that this past month several arrests were made for car and home burglaries. They are doing an outstanding job keeping the community safe. He also thanked the Ambulance Corp. for taking care of the residents of the Township.

Comm. Ouellette – No Report

Comm. Valenzuela – Fire Department January Report – 12 Calls

Valenzuela thanked the Fire Department for their continued volunteerism. He then informed the resident of a meeting with himself, Administrator De Maria, Comm. Davidson and Administrator/Clerk Lo Dico and Mayor Chamberlain of Saddle Brook to discuss possible shared services. He will continue to look for ways to save the Township money utilizing shared service agreements between local municipalities.

Mayor Kovalcik – Ambulance Department January Report – 70 Calls

Kovalcik thanked Capt. Roland Jacobsen, Ben Varghese and Steven Cassiello for an excellent job. The Ambulance Corp. continues to work well with neighboring communities. The Mayor read a letter from Fire Chief Al Carroll thanked Capt. Jacobsen for accommodating the Fire Department in their CPR recertification efforts. Kovalcik advised the results of the Township’s recent bond sale, he advised that they had received an interest rate of 2% which coincides with the Township A credit rating. This reinforces that financially the Township is fiscally responsible and conservative.

Administration De Maria – Reminded everyone that the municipal offices would be closed on Monday, Presidents Day. She advised that the Township had received \$9,000 from FEMA and was looking forward to another payment of \$224,000 which is still under review. She asked the Committee to call a special meeting to introduce the Bond Ordinance. The Township Committee agreed to a special meeting to determine the date shortly.

Comm. Valenzuela – advised that the School Board had decided to move the School Board Election to November.

A RESOLUTION – COLLECTION & TRANSPORTATION TO DESIGNATED DISPOSAL FACILITY OF GARBAGE, ASHES & REFUSE

WHEREAS, on January 19, 2012, bids were received for the Collection & Transportation to Designated Disposal Facility Garbage, Ashes & Refuse from Residences, Municipal Properties and Public Schools for the Township of Rochelle Park; and

WHEREAS, six (6) bids were received, opened and read; and

WHEREAS, the Township Engineer’s review of said bids found that the bid submitted by Miele Sanitation Co., 60 Railroad Avenue, Closter, NJ 07624 was “non-responsive” and rejected; and

WHEREAS, the bids submitted by Gaeta Recycling, 278-282 West Railroad Avenue, Paterson, NJ 07503 and Joseph Smentowski, 3 New York Avenue, Jersey City, NJ 07306 contained mathematical errors; and

WHEREAS, said mathematical errors were corrected in accordance with the provisions of the Bid (Uniform) Specifications; and

WHEREAS, the low bidder for Proposal Items 1a, 1b, 2a, 2b, 3a and 3b was submitted by Future Sanitation & Recycling, 80 Liberty Street, Passaic, NJ 07055 for the following total amounts:

WHEREAS, the Future Sanitation and Recycling bid utilized the same per year cost for year round bi-weekly collection of the entire Township and bi-weekly collection of the entire Township for the months May-September; and

WHEREAS, upon review of the bids submitted, it is the position of the Township Committee of the Township of Rochelle Park that the municipality would be best served by the award of a contract for the Collection and Disposal of Garbage, Ashes and Refuse from residences, municipal properties and public schools for with round bi-weekly collection for a period of five (5) years (proposal Item 3a).

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Rochelle Park, County of Bergen, State of New Jersey, that the contract for the Collection & Transportation to Designated Disposal Facility of Garbage, Ashes & Refuse for a five (5) year period for a year round bi-weekly collection Proposal item 3a be and is awarded to Future Sanitation and Recycling, 80 Liberty Street, Passaic, NJ 07055, the low bidder for the total bid amount of \$505,800.00; and
