

NOTICE TO BIDDERS

TOWNSHIP OF ROCHELLE PARK

Notice is hereby given that sealed bids will be received by the Township of Rochelle Park, County of Bergen, State of New Jersey for the State Aid Improvement of Lincoln Avenue from Chestnut Avenue to Peek Street, and Chestnut Street from Rochelle Avenue to its Westerly Terminus, in accordance with plans and specifications prepared by Job and Job Consulting Engineers, and opened and read in public at the Municipal Building, 151 West Passaic Street, Township of Rochelle Park, New Jersey on Friday, April 7, 2017 at 10:00 AM prevailing time or as soon thereafter as the matter may be reached.

Information for Bidders, Form of Proposal, Specifications and other Contract Documents may be examined by properly qualified Contractors between the hours of 10:00 AM and 4:00 PM daily, except Saturdays, Sundays and Holidays and on the day of receiving bids at the office of Job & Job Consulting Engineers, 108 Hudson Street, Hackensack, New Jersey and copies may be obtained upon payment of Two Hundred Fifty Dollars (\$250.00) per set, no part of which is refundable.

The Township Committee reserves the right to waive any informalities in or to reject any or all bids, or to accept the one that in its judgment will be for the best interests of the Township.

Bids must be prepared on standard Proposal Forms in the manner designated therein and required by the specifications and must be enclosed in sealed envelopes bearing the name and address of bidder and title of bid on outside, addressed to the Township Committee, Township of Rochelle Park and must be accompanied by an executed Non- Collusion Affidavit, Standard Consent of Surety and Certified Check or Bid Bond made payable to the Township of Rochelle Park for not less than ten percent (10%) of the amount of bid, and be delivered at the place and on the hour above named.

The Successful bidder will be required to furnish a Payment and Performance Bond in approved form and with sureties satisfactory to the Township Committee, Township of Rochelle Park which bond shall be in the amount in the Contract.

Bidders on this work shall be required to pay the Prevailing Wage Rates for the locality in which the project is being performed. Prevailing Wage Rates shall be determined by the New Jersey Prevailing Wage Acts, Laws of 1963, Chapter 150 (R.S. 34:11 - 56:25 et seq.).

Bidders are required to comply with N.J.S.A. 10:5-31 et. seq., and N.J.A.C. 17:27-7.3. The bidder shall also comply with P.L. 1977, Chapter 33, concerning identifying stockholders or partners as specified herein.

All bids shall be irrevocable, not subject to withdrawal and shall stand available for a period of sixty (60) days.

The Township of Rochelle Park reserves the right to hold for consideration for a period of sixty (60) days, the three (3) lowest bids, the check or bid bond and consent of surety accompanying same, after which the said three (3) lowest bids will be notified of the action of the Township Committee and the deposits of the unsuccessful bidders returned. The deposits of all other bidders will be returned within one (1) week after the opening of bids, or may be obtained from the Township Clerk at the close of the meeting at which said bids were opened. The right is expressly reserved to reject any or all bids and waive any defects or informalities in any bid and to accept the bid to be in the best interest of the Township of Rochelle Park.
