A Resolution – Authorizing Action on the POL/EPL Premium Options - JIF

Whereas, the Township of Rochelle Park (hereinafter, the Township) is a member of the South Bergen Municipal Joint Insurance Fund (hereinafter, the JIF) for all Property and Casualty coverages (including but not limited to Property, General Liability, Inland Marine and Workers Compensation) and more specifically, Public Officials Liability and Employment Practices Liability (hereinafter, POL/EPL) coverage; and

Whereas, the POL/EPL coverage is provided by XL Insurance Company, through a separate insurance contract held by the JIF on behalf of its member municipalities; and

Whereas, the 2013 renewal program offered by XL Insurance Company allows for various options to change both deductibles and co-insurance, at an additional premium; and

Whereas, the Municipal Risk Management Consultant (hereinafter, the RMC) has performed due diligence in reviewing the options and provided a recommendation for consideration during a recent public meeting of the Governing Body; and

Whereas, the Governing Body, after reviewing and discussing the options presented and recognizing the timeframe for action does hereby agree to take action.

Now, therefore be it resolved, by the Mayor and Committee of the Township of Rochelle Park, County of Bergen, State of New Jersey, the Township Clerk and RMC are hereby authorized and directed to effectuate the following option:

\$7,500 Deductible with a 0% Co-Insurance
