**ORDINANCE #1270-26**

**AN ORDINANCE TO AMEND CHAPTER 127 ENTITLED  
“LITTERING” OF THE TOWNSHIP CODE OF THE  
TOWNSHIP OF ROCHELLE PARK, STATE OF NEW JERSEY**

**BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF ROCHELLE PARK IN THE COUNTY OF BERGEN AND STATE OF NEW JERSEY, AS FOLLOWS:**

**WHEREAS**, Chapter 127 of the Code of the Township of Rochelle Park sets forth all regulations regarding Littering in the Township of Rochelle Park; and,

**BE IT ORDAINED**, by the Mayor and Committee of the Township of Rochelle Park, County of Bergen and State of New Jersey that those portions of the aforesaid set forth below are hereby amended as follows and that those portions of the Ordinance not set forth below shall remain unchanged.

**Sec. 127-9. Handbills.**

B. No person shall place, cause to be placed or suffer or permit to be placed, distribute or deliver any newspapers, advertisement, advertising circulars, flyers, handbills or any and all similar printed materials upon any door, railing, entranceway, stoop or other location upon any premises within the Township in a manner likely to be blown or carried by wind and become litter. No such materials shall be deposited in a manner that results in accumulation in and on streets, gutters, catch basins, storm drains or other public rights-of-way. Such materials shall be placed at or near the primary entrance of the residence, within a newspaper receptacle or in another location reasonably calculated to prevent displacement by wind, weather or passing traffic.

**Severability.**

If any section, subsection, clause, or provision of this Ordinance shall be adjudged by a court of competent jurisdiction to be invalid, such adjudication shall not affect the validity of the remaining provisions, which shall remain in full force and effect.

**Repealer.**

All ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

**Effective Date.** This Ordinance shall become effective upon final approval and publication, pursuant to law, and upon completion of all outstanding cases.
